A CALL FOR PARTNERSHIP TO SUBMIT EXPRESSION OF INTEREST FOR PARTNERSHIP WITH VI AGROFORESTRY DURING 2023-2027 PROGRAMME CYCLE

Introduction

Vi Agroforestry is a Swedish development organisation working with local communities in fighting poverty and climate change through Agroforestry. The organisation has been working in East Africa since 1983.

Vi Agroforestry partners with local organisations in the region for the realisation of shared vision and ambition towards fighting poverty and climate change for improved livelihoods of smallholder farmers. Together, we offer outstanding expertise in agroforestry, climate change adaptation and mitigation, promoting innovative, well-proven sustainable land management practices based on scientific research in a manner that supports sustainable livelihoods for women and men, taking special consideration for female and male youth.

Currently, Vi Agroforestry is developing a new programme that will guide the organisation's operations during the next strategy period, 2023-2027. The programme will focus on the following key working areas;

- Organisational development – Supporting organisational capacity of member-based farmer organisations
- Food and nutrition security
- Climate change resilience
- Biodiversity conservation
- Sustainable livelihoods
- Sustainable agriculture land management
- Sustainable land management in Arid and Semi-Arid Lands (ASALs) including water management
- Sustainable Agriculture and nature-based value chains
- Advocacy actions in related areas
- Innovations for youth in agribusiness

We are also keen on interphase of these working areas with humanitarian and peace building efforts. This nexus is therefore an area of interest for Vi Agroforestry.

The programme and implementation will use a gender transformative approach (GTA) and human rights-based approach to development (HRBA).

Towards realisation of the strategy ambition, Vi Agroforestry seeks to scan and identify potential partners working in Uganda , Kenya and Tanzania .

Our partnership categories

We have three categories of partnerships as described below.

Type of partners	Description
Core partners	<p>These are the small holder member-based farmers' organisations. The membership in these organisations enables the reach to the grassroots. The focus here is to strengthen the capacity of these organisations to engage duty bearers, while at the same time having the ability to provide a support system to the members.</p> <p>Economic empowerment through value chain development is mainly with this category of partners including capacity building on environment and climate change issues, and adoption of agroforestry and SALM at farm level. Women empowerment and children and youth issues are also a key focus.</p>
Technical partners	<p>These are organisations that might not necessarily be member based but have specialised capacity and skills that could be a gap for the core partners. Issues such as, value chain & business development, children and youth engagement might require support from organisations who specialise in this. Vi Agroforestry will engage technical partners to provide the required capacity and support to the core partners when it is efficient to do so.</p>
Strategic partners	<p>These are regional bodies, research organisations, universities, peer organisations, among others that are relevant to our working areas. Vi Agroforestry is keen on strengthening alliances and building relationships that make it efficient to jointly take action such as co-designing interventions for bigger impact.</p>
