- e) Letter of recommendation from three of your major clients indicating contact person(s) and their telephone number indicating the types and or forms of works/services previously done with them and can be verifiable.
- f) Bank statements for the last three months.
- g) Company profile that shall include details of the management team.
- **h)** Where mandatory for service provision (e.g. audit, legal and engineering services), each firm must provide evidence of registration with various professional bodies/ Authorities.

Interested eligible service providers are invited to submit tenders, indicating the

service (s) they wish to provide. The completed documents must be submitted
